RESOLVED, That that certain agreement made and entered into by and between J.H.McNichols, of Los Angeles, County of Los Angeles, State of California, party of the first part, and Merle Graybeal, of Castleford, County of Twin Falls, State of Idaho, party of the second part, under date of January 13, 1932, wherein it is agreed that assessments of the American Falls Reservoir District heretofore levied against the Northwest Quarter (NW $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 10, Township 11 South, Range 17, E.B.M., part south and southwest of "High Line" Canal, for the purchase of a water right supplemental to 12 shares of the stock of the Twin Falls Canal Company, shall be chargeable to the Southeast Quarter (SE $\frac{1}{4}$ ) of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section 19, Township 11, South, Range 14, E.B.M., Twin Falls County, Idaho, and that said assessments shall be effective in all respects against said land, shall be, and the same is hereby ratified and approved; and,

Dear Mr. Shepherd:

I do not of course know what your plans are regarding investments of the American Falls Reservoir district's safety funds. The liberty bonds are up well in price now, owing, I think, largely to government support in preparation for the issuing of new U.S. bonds. It strikes me that this might be a good time to dispose of the liberties.

I wish also to call your attention to the fact that we shall call for bids for the sale of general fund treasury notes, probably around the 24th of March. My best information is that they will have to bear around 6% interest at par and possibly we will not be able to sell them at that on account of the money stringency. In case you care to sell the liberty bonds, it might be a good stroke of business to put the money in State Treasury Notes at a high rate and at the same time help with our financing here. We of course will be able to get along, I feel sure, without defaulting on any payments, but I don't like to pay 6% interest to New York.

I just thought I would call this to your attention and hoping that everything is well with you, I remain,

Whereupon the Secretary called to the attention of the board that the statutes provide (Chapter 125, Sec. 4384, 1931 Session Laws) that assessment books be provided "on or before June 15th of each year," and that levies be



made "on or before the third Tuesday of July", and asked that the levy of operation and maintenance for the fiscal year of 1932 and 1933, beginning November 1st, 1932, be made at this time.

Whereupon, a motion was made by Director W. H. Spence, seconded by Director J. H. Barker, that the following resolution and order be adopted, namely:

WHEREAS, it is provided by the statutes that the board of directors shall meet at the office of the district on or before the third Tuesday of July of each year and proceed to levy an assessment upon all the lands of the district for the purpose of defraying the expenses of the organization of the district, and of the care, operation, management of the district's affairs, the maintenance of the district organization, including salaries of officers and employees, and maintaining and operating the property of the district:

NOW, THEREFORE, it is RESOLVED and ORDERED, by the Board of Directors of the American Falls Reservoir District, an irrigation district organized and existing under and by virtue of the laws of the State of Idaho, that an assessment be, and the same hereby is, levied upon all the lands of the American Falls Reservoir District to defray the expenses of the organization of the district and the care, operation, management of the district affairs, the maintenance of the district organization, including salaries of officers and employees and maintaining and operating the property of the district for the year 1932 and 1933 at the rate of 5¢ per acre foot of storage capacity as purchased for lands as follows:-

Further reference is made to my letter to you of May 10, in reply to yours of May 3, in which you requested a deferment to June 30, 1933 of the instalment of principal in the amount of \$9,260.00 due June 30, 1932 under the district's contract of June 30, 1931, for the purchase of 20,000 acre feet of storage in American Falls Reservoir, Minidoka project.

A copy of C. L. 1995 is enclosed to which is attached a copy of the 1932 Reclamation Relief Act. Sec. 4 of the Act permits the deferment of one-half of the construction charge instalment of \$9,260.00, and the \$4,630.00 so deferred would bear interest at the rate of five per cent per annum payable annually. The deferred amount would be payable after the other charges shall have come due, but the Department has ruled that payment may be made at an earlier date, if desired, and your district may desire to make payment at an earlier date, to stop the running of interest.

Please advise whether this extension under the 1932 Reclamation Relief Act will meet the needs of your district. I am inclined to think that a deferment of the entire instalment of \$9,260 due June 30, 1932, would not be justified, as there would be no warrant for treating Warren Act contractors more favorably than the regular project water users.

If it is decided to ask for a postponement under the 1932 Reclamation Relief Act, the District should adopt a resolution in the form set out in C. L. 1995.

Pursuant to the act of Congress approved by the President on April 1, 1932 and the acceptance of the provisions of said act by resolution of the Board of Directors of the American Falls Reservoir District, the district's regular construction charge under its contract with the United States dated June 30, 1931, for the calendar year 1932 in the amount of \$9,260.00, less 50 per cent thereof, or \$4,630.00, is hereby extended and made payable in one instalment in the year following the year the last instalment under the above mentioned contract shall become due.

It has been further determined that the charge deferred under this act shall be subject to an annual interest rate of 5 per centum, payable annually on June 30, in the amount of \$231.50 until the principal sum deferred has been paid or reduced by partial payments.

In circular letter No. 2000 dated May 20, 1932, issued by the Bureau of Reclamation, the district was advised of a departmental ruling that partial payments may be made from time to time on the charge deferred. Should the district elect to liquidate the obligation on this basis appropriate credits will be given the district, whereupon the annual interest charge will be reduced accordingly in proportion to the payments made on the principal.

THIS AGREEMENT, Made this      day of      , 1932, in pursuance of the act of Congress of June 17, 1902 (32 Stat., 388), and acts amendatory thereof or supplementary thereto, all of said acts being hereinafter styled the Reclamation Law, between the UNITED STATES OF AMERICA, hereinafter styled the United States, represented by the contracting officer executing this contract, the AMERICAN FALLS RESERVOIR DISTRICT, hereinafter styled the District, a corporation organized and existing under the laws of the State of Idaho and having its principal place of business at Twin Falls, Idaho, and the IDAHO POWER COMPANY, hereinafter styled the Power Company, a corporation organized and existing under the laws of the State of Maine but authorized to do business in the State of Idaho and having its principal place of business at Boise, Idaho.

WITNESSETH, That:

2. WHEREAS, under article 6 of contract of June 1, 1931 between the United States, the Power Company, and the District, it is provided:

"The term of this contract shall extend from the date hereof until October 31, 1931, but the District may, at its option, extend this contract until October 31, 1932 by paying to the United States the further sum of \$50,000 on or before November 1, 1931, and may at its option further extend the same until October 31, 1933 by paying to the United States the further sum of \$50,000 on or before November 1, 1932, and may at its option further extend the same until October 31, 1934 by paying to the United States the further sum of \$50,000 on or before November 1, 1933, and may at its option further extend this contract until October 31, 1935 by paying to the United States the further sum of \$50,000 on or before November 1, 1934; but this contract shall not extend beyond October 31, 1935 and it is understood that no water out of the Gooding division's share of said reservoir is to be included in this rental after the season of 1931";

and



3. WHEREAS, the District is unable to exercise its option by payment of \$50,000 on or before November 1, 1932, but is willing to contract to pay two-thirds of that amount; and

4. WHEREAS, on account of extreme low prices for farm products many of the irrigation companies and irrigation districts which participated during the irrigation seasons of 1931 and 1932 in the use of the stored water provided in said contract and contributed to the payment therefor are now unable to make the required payments at the rates and upon the terms necessary under the said contract but can pay for the same upon the terms and rates hereinafter set out;

5. NOW, THEREFORE, it is agreed that in lieu of the option given the District in Article 6 of said contract of June 1, 1931 to extend the life of the said contract to October 31, 1933 by paying to the United States the sum of \$50,000 on or before November 1, 1932, the District hereby contracts for such extension up to October 1, 1933, and payment therefor is to be made to the United States as follows: \$14,000 in cash on or before December 1, 1932, \$9,666.67 on or before March 1, 1933 and \$9,666.67 on or before June 1, 1933, a total of \$33,333.34. The options exercisable by the District under Article 6 of said contract of June 1, 1931, to extend the contract to October 31, 1934 and October 31, 1935, respectively, under the conditions stated in said Article 6 are not to be affected by the provisions of this supplementary contract.

6. It is further agreed and understood that the United States shall not be obliged to furnish any of said stored water during the irrigation season of 1933 until the District shall have completed payment of the said full sum of \$33,333.34.

7. In all other respects the said contract of June 1, 1931 shall remain unchanged and in full force and effect.

8. No member of or delegate to Congress, or resident commissioner, shall be admitted to any share or part of this contract or agreement, or to any benefit to arise thereupon. Nothing, however, herein contained shall be construed to extend to this contract if made with a corporation for its general benefit.

Hurlebaus, husband and wife, of Jerome, Idaho, parties of the second part, under date of March 15th, 1932, wherein it is agreed that assessments of the American Falls Reservoir District heretofore levied against 40 acres of the West Half (W $\frac{1}{2}$ ) of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section 10, Township 6 South, Range 13, E.B.M., Gooding County, Idaho, for the purchase of a water right supplemental to 40 shares of the stock of the North Side Canal Company, shall be chargeable to the Southwest Quarter (SW $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section 34, Township 8 South, Range 15, E.B.M., Gooding County, Idaho; and that said assessments shall be effective in all respects against said land, shall be, and the same is hereby ratified and approved; and,

Report of collateral in hands of County Auditor of Jerome County as security of our deposit in First Security Bank of Jerome was read and on motion of Director W. H. Spence, seconded by Director H. K. Wiley, was approved and ordered filed.
